An inspection by our Division has determined this property is in violation of Bay County Code Section 17-2 - Prohibitions in the form of junk, tree/yard debris, overgrowth, derelict vehicles, and unscreened/ unused personal property.

The following action must be taken to correct the above stated violation(s):

- 1. All junk and debris must be removed from the property and disposed of lawfully.
2. All overgrown grass or weeds must be cut or mowed.
3. Derelict vehicles must be stored in an enclosed structure, made operable with current registration, or removed from the property.
4. All unscreened, unused personal property must be screened, properly stored, or removed from the property.

This correspondence will serve as official notification that the above stated violation must be corrected before July 5, 2022.

This case is scheduled to be presented to a special magistrate at the hearing on July 7, 2022, at 9:00 a.m., at the Bay County Government Center located at 840 W. 11th St., Panama City, Florida. If found in violation, the magistrate may order that the violations be corrected. Fines, liens or special assessments may be placed on the property for non-compliance and/or the costs of abatement by the County.
